- 1. By-law No 243 is amended by ADDING to Section 3.2.6 Industrial/Business Park Designation the following policies:
 - 3.2.6.4 It is a policy that within the Industrial designation, Council shall permit Industrial and Intensive Resource zones.
 - 3.2.6.5 It is a policy that Abattoirs are only permitted in the Intensive Resource zone, through a rezoning by development agreement. In considering a request, Council shall consider the separation between residential neighbourhoods, methods of disposal of any non-domestic waste, health and environmental considerations.
