By-law No. 243, the Town of Sackville Municipal Plan, is amended by changing the designation as shown on the Future Land Use Map Figure "2" of the Town of Sackville Municipal Plan for a portion of the property identified as PID 00898114 as shown on Schedule A attached hereto and forming part hereof, from Industrial to Rural Residential.



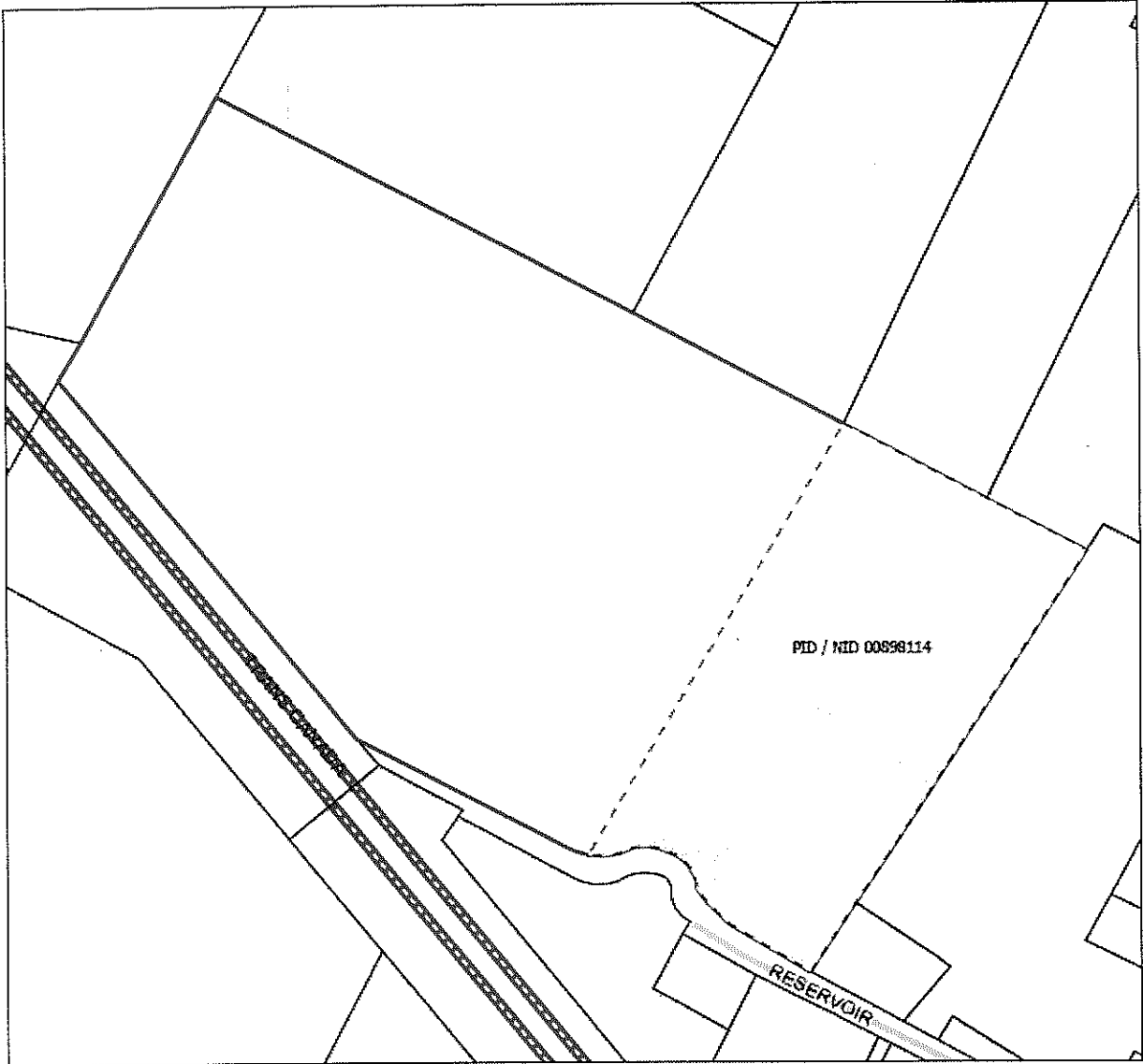
