1. By-law No 244, the Town of Sackville Zoning By-law, is amended by changing the zoning as shown on the Zoning Map Figure "1" of the Town of Sackville Zoning By-law for the portion of the lands indicated by the shaded area on Schedule "A" attached hereto and forming part hereof, from Industrial (IND) to Rural Residential (RR).

Read a second time this 11<sup>th</sup> day of January, 2021.

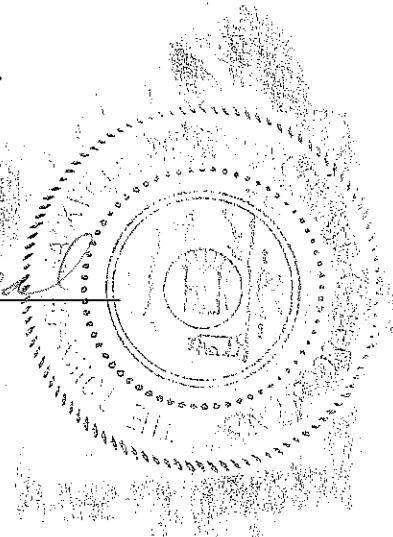
Read a third time and passed this 8<sup>th</sup> day of February, 2021.

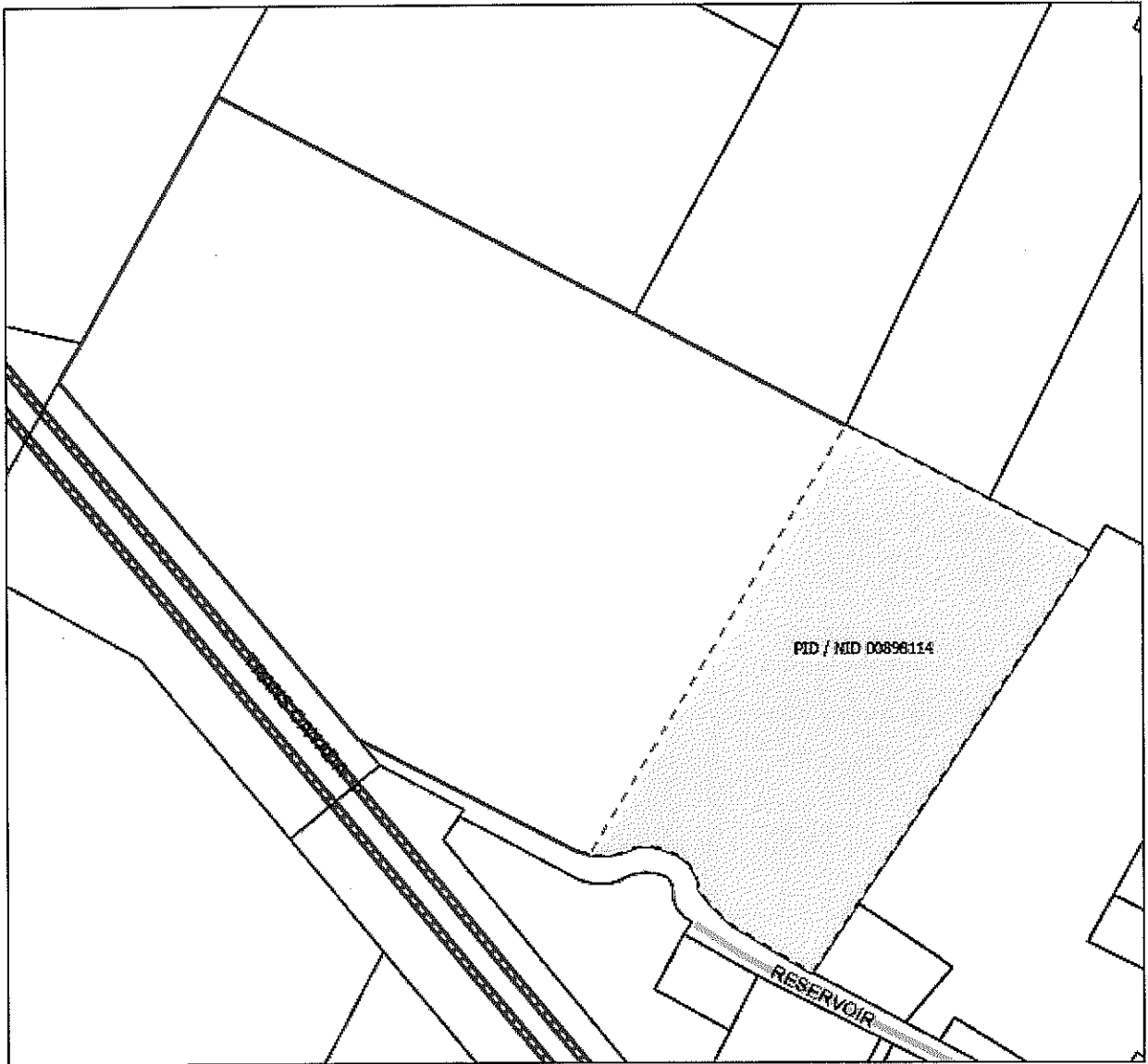
