**BY-LAW NO. 244-E  
A BY-LAW TO AMEND BY-LAW NO. 244  
TOWN OF SACKVILLE ZONING BY-LAW**

The Council of the Town of Sackville under the authority vested in it by Section 53 and in accordance with Section 59 of the *Community Planning Act*, SNB 2017, c.19 amends By-law No. 244, the Town of Sackville Zoning By-law and enacts as follows:

1. By-law No. 244, the Town of Sackville Zoning By-law, is amended by changing the zoning as shown on the Zoning Map Figure "1" of the Town of Sackville Zoning By-law for a portion of the property identified as Parent PID 70553284 as shown on Schedule A attached hereto and forming part hereof, from Highway Commercial (HC) to Institutional (I) for the purpose of operating an ambulance service; and
2. Establishes the maximum front yard setback at 15.24 m (50').

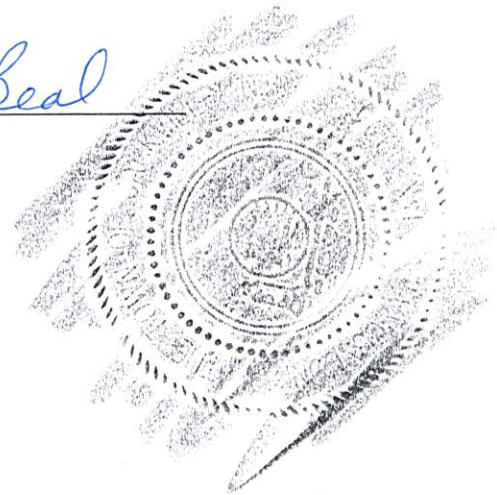

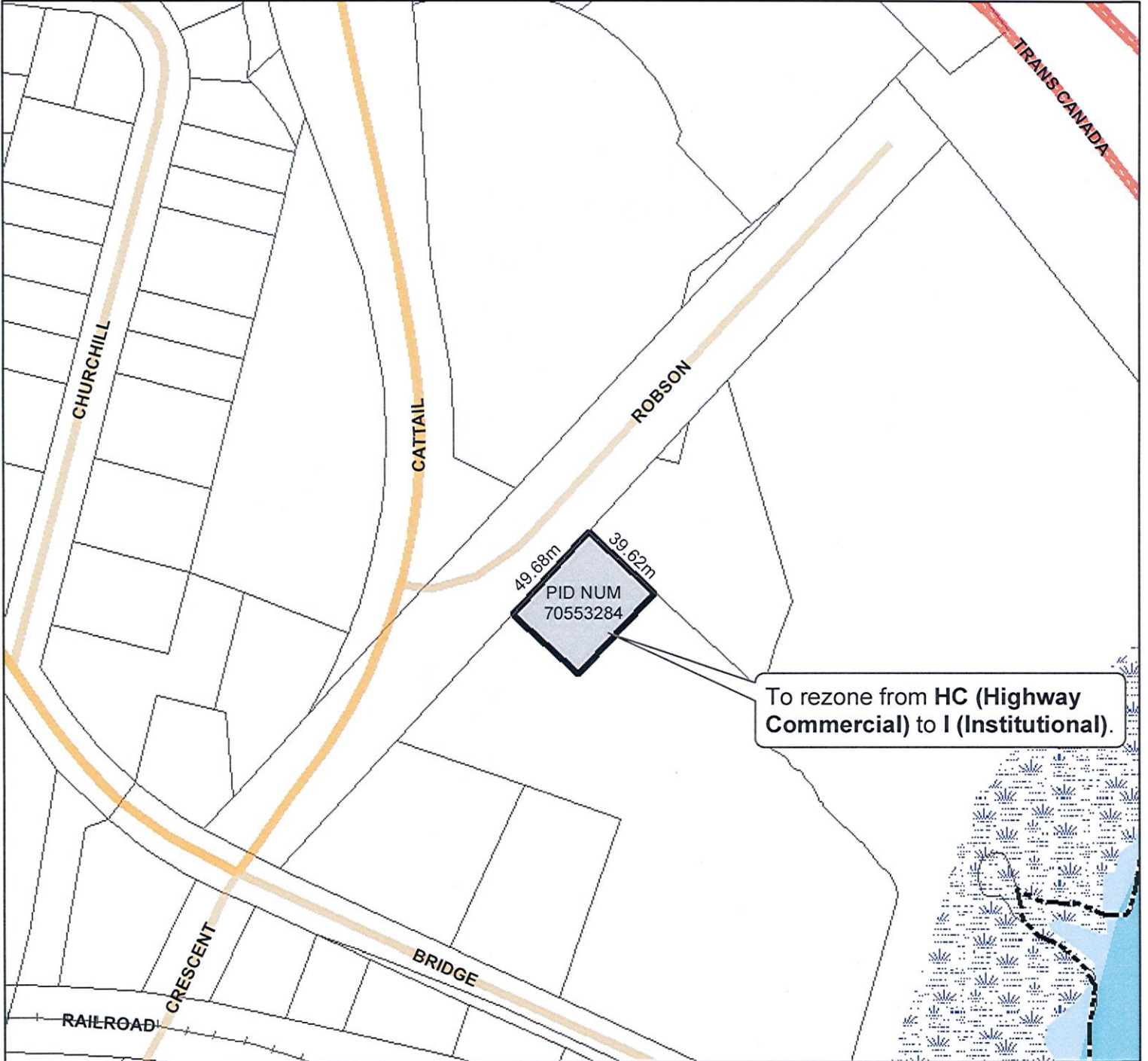
