TOWN OF SACKVILLE ZONING BY-LAW**



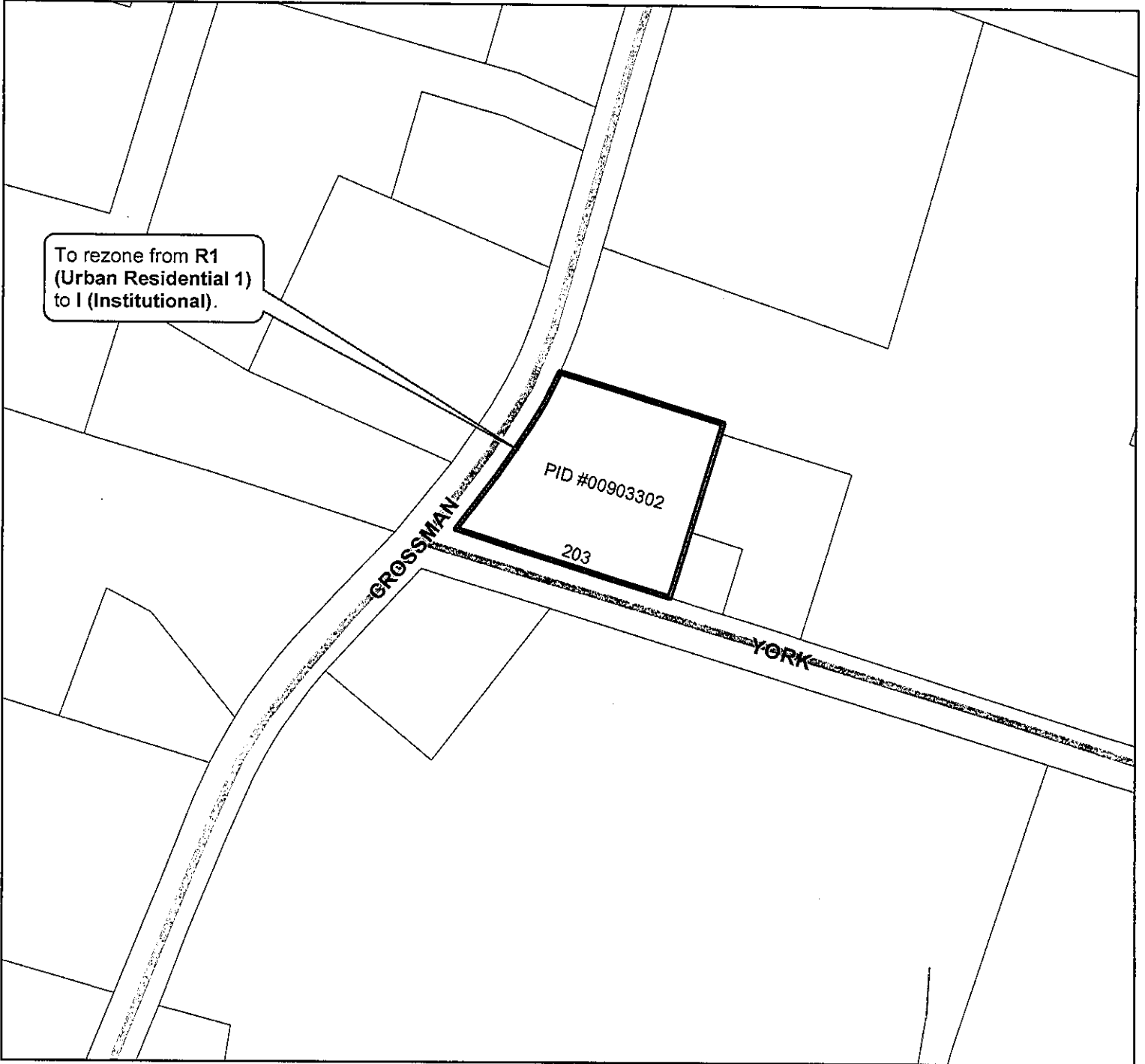

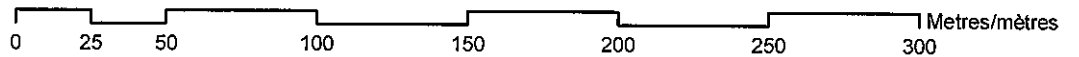
